### **Overview**

A leading international communications company with a customer base of more than 100 million across the Middle East, North Africa, and Southeast Asia known for delivering world-class services for consumers, businesses, residences, and organizations. The company struggled with security alerts, unmonitored assets, and outdated infrastructure, limiting its ability to offer robust cybersecurity services to B2B partners.

## Client Background and Challenge

They needed a robust and secure framework for their cyber security operations and partner network. However, the company faced critical challenges, including:

- (a) 30,000+ alerts causing poor analysis of the threats and further recommendations.
- **45+ unmonitored assets**, unpatched systems, and outdated EOL/EOS licenses and subscriptions, leading to security vulnerabilities.
- ( Inadequate on-premises infrastructure with limited support and maintenance.
- Security Information and Event Management (SIEM) and Non-Person Entity (NPE) offerings to B2B partners, as well as limited cybersecurity service portfolio offerings, impacted the sustainability of the existing customer.

## Our Approach and Solution

To address these challenges, Tech Mahindra implemented a comprehensive cybersecurity transformation incorporating:

### **People**

- Onboarded a transition team within one week of the deal being awarded.
- Leveraged the **multi-skilled MSSP resources** with the cost-effective hybrid model.

## Process

- ( ) Implemented a three-tier governance model.
- Transitioned the SOC operation from the hostile situation within the lead time with zero escalations.

## Technology

- Patched eight servers, replaced faulty hardware, and extended support warranties.
- Prepared a well-defined maintenance calendar to improve the availability of the **SIEM platform**.


