
- NetSuite ERP Core Modules: Deployed functionalities spanning finance, procurement, inventory, order-to-cash, CRM, and demand/supply planning.

- Cloud-Based Deployment: Leveraged NetSuite's cloud infrastructure for anytime-anywhere access without the burden of on-premises hardware.


