Disclosure of Voting Results as per Clause 35A of the Equity Listing Agreement with the Stock Exchanges of the Court Convened Meeting of the Company convened pursuant to the Order of the Hon'ble High Court of Judicature at Mumbai on June 20<sup>th</sup> 2014.

This is to inform you that the resolution for approval of the proposed Scheme of Amalgamation and Arrangement of Mahindra Engineering Services Limited, the Transferor Company, with Tech Mahindra Limited, the Transferee Company under Sections 391 and 394 of the Companies Act, 1956 ("Scheme"), was approved by the shareholders at the Court convened meeting held at Mumbai on 20th June 2014 by requisite majority. The results of the poll are attached as Annexure A to this letter.

Kindly note that in accordance with the terms of the SEBI Circulars, the Scheme also needs to be approved by the public shareholders of the Transferee Company such that the votes cast by public shareholders in favour of the Scheme are more than the votes cast by the public shareholders against the Scheme, through postal ballot and e-voting. The results of the postal ballot and e-voting for the resolution for approval of the proposed Scheme of Amalgamation and Arrangement of Mahindra Engineering Services Limited with Tech Mahindra Limited under Sections 391 and 394 of the Companies Act, 1956 would be available on or before 27<sup>th</sup> June 2014 and therefore the resolution remains subject to such approval. Results of the postal ballot/e-voting would be separately disclosed to the stock exchanges.
