# Sub.: Furnishing of PAN, KYC details and Nomination by holders of physical securities

# Ref.: SEBI Circular No. SEBI/HO/MIRSD/MIRSD\_RTAMB/P/CIR/2021/655 dated November 3, 2021

As you may be aware that SEBI vide the subject circular dated November 3, 2021, mandated the following requirements for the holders of physical securities:

- a. furnishing of PAN, email address, mobile number, bank account details and nomination;
- b. any service request shall be entertained only upon registration of the PAN, bank details and the nomination;
- c. to ensure that PAN is linked to Aadhaar by March 31, 2022 or any other date as may be specified by the Central Board of Direct Taxes to avoid freezing of the folio.

Communication in this regard has been sent by our Registrar & Transfer Agent, Link Intime India Private Limited (R&T Agent) to the holders of physical securities on their registered address.
